PERSONAL GAIN MAY RESULT NOT ONLY IN CASES WHERE AN EMPLOYEE, BOARD MEMBER OR RELATIVE HAS A SIGNIFICANT OWNERSHIP IN A FIRM WITH WHICH NAHPC DOES BUSINESS, BUT ALSO WHEN AN EMPLOYEE, BOARD MEMBER OR RELATIVE RECEIVES ANY KICKBACK, BRIBE, SUBSTANTIAL GIFT, OR SPECIAL CONSIDERATION AS A RESULT OF ANY TRANSACTION OR BUSINESS DEALINGS INVOLVING NAHPC.
