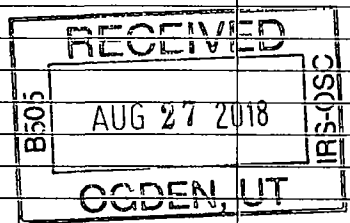

Part IX-A, Summary of Direct Charitable Activities

The Foundation provided tutoring services to students in classes the Foundation adopted at Charles Drew Elementary School in Liberty City; Frederick Douglas Elementary School in Overtown; Phillis Wheatley Elementary School in Overtown, and Holmes Elementary School in Liberty City. The schools are located in low-income neighborhoods and the tutoring services are available for each of the students within the adopted classes. Tutoring services are provided for the students at the school and the Foundation pays for the tutoring services on behalf of the students.

In 2010 the Charles Drew Elementary School's first grade class adopted in 1999 graduated high school with a 89% on time graduation rate and 97% overall graduation rate. In 2017 and 2018, students from Frederick Douglas, Phillis Wheatley and Holmes Elementary schools graduated with a combined 77% on time graduation rate. The Foundation is providing tuition assistance of up to \$2,500.00 per year for those students who are attending private or out of state school. For students attending a Florida state school, they are provided with a Florida Prepaid Tuition scholarship with covers their tuition up to 120 credits.

In June of 2018, the Foundation entered into a partnership with KIPP Miami Sunrise Academy, a brand new local charter school, to provide mentoring services and after school academic and enrichment programming to their inaugural kindergarten and first grade classes, comprising of an anticipated 216 students. KIPP Miami Sunrise Academy is located in Liberty City serving children and families from the community with the shared goal of increased on time high school graduation and college matriculation.

None of the students in the adopted classes are family members or a "disqualified person" with respect to the Foundation.

NARRATIVE OF EXEMPT ACTIVITIES

Bayview Foundation Inc (Foundation) was created in January 1999 for the purpose of promoting and fostering the education of under-privileged youth. The Foundation “adopted” the entire first grade class of Charles Drew Elementary School in Liberty City, Florida in February 1999, which was comprised of 96 students. Since “adopting” the original class, the Foundation has adopted 4 new classes. The new classes are located at Frederick Douglas Elementary School in Overtown (10/05); Phillis Wheatley Elementary School in Overtown (10/05), and; two classes at Holmes Elementary School in Liberty City (3/06). In addition, the Foundation has performed various activities in furtherance of its exempt purposes of fostering the education of the students, including the following:

- Work with Miami-Dade Public Schools to develop a comprehensive curriculum for a summer program for the students.
- Provide tuition assistance of up to \$2,500 per year or a Florida Prepaid scholarship for up to 120 credits for every member of the first grade classes graduated in 2010, 2017, & 2018 that gained admission to a two or four year accredited college or university.
- Provision of tutoring and enrichment services for each student.

Much of the Foundation’s activity since its inception has been the provision of tutoring and enrichment services to the students. The Foundation employs several Project Coordinators that arrange for the tutoring services needed by the students. The coordinators place the tutors with the students to meet their educational needs.

In 2016 Bayview Foundation took 45 10th grade Dreamers on a Florida state college tour, visiting 8 schools over the course of a week. In addition to exposing the Dreamers to the college life, the Foundation provided intensive preparation for the ACT and the revised SAT. In 2016, Bayview Foundation also launched their first internship program where Dreamers had to prepare their resumes and interview for intern positions at Bayview Financial. The Dreamers had the opportunity to intern within the different departments at Bayview and gain valuable workplace skills.
