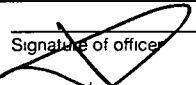

The purpose of the Corporation is to support people and programs that build a stronger Puerto Rico. The range of areas to be supported would include but not be limited to education, health, the environment, economic development, disaster preparedness and response and community partnerships. A special emphasis would be on activities in Culebra, Puerto Rico

We supported the Cruz Roja, the Red Cross Chapter in Puerto Rico. We have recruited volunteers who have been trained as disaster volunteers. We have also worked with Cruz Roja to stockpile materials and supplies such as tarps and clean-up kits, to be available for any significant event such as a hurricane. We continue to serve as disaster responders, handling small events such as house fires. The impact of Hurricane's Irma and Maria was catastrophic. It quickly became clear that response and recovery was going to take both government and private efforts. The Foundation immediately began identifying critical unmet needs such as generators for the health center and schools in Culebra and cisterns for isolated communities in PR without access to clean water. The Foundation is continuing to address needs such as restoration of the Culebra health center and internet services for vital government services. The is also working to help people whose homes were totally destroyed. FEMA is completing its work and providing some financial support. We have worked with a local architect, who has worked pro bono to develop plans for replacement housing that be safe in future storms. The Foundation be determining how to assist if the FEMA funds are not adequate

The Foundation supported and collaborated with existing organizations that are doing philanthropic or community programs to build a stronger Culebra and Puerto Rico. During the year, the Foundation supported the following charitable entities: (a) Radio Vieques 90.1 FM, a community based radio station staffed by volunteers, was launched in 2013 to give the people of Culebra and Vieques a real outlet for their voices to be heard. (b) The Culebra Foundation, a 20-year-old wonderful organization dedicated to research and preservation of the history of Culebra and its people. (c) Friends of Culebra Animals, a volunteer group that ensures the humane treatment of animals on our island. A team of vets who came to the island once a month to provide veterinary services to animal welfare. (d) Proyecto Siembra is an initiative that promotes education regarding ecological principles for planting and growing. The project is in charge of maintaining a community orchard that encompasses all the green spaces of SEVA, the old school of Culebra. Children are taught about compost, maintenance of seed banks, and different ecological planting techniques. The project also built a hen house which collects fresh eggs. (e) Project LAUNCH's mission is to promote the welfare and healthy development of newborns, newborns and their families up to eight years of age. The project strives to ensure that newborns and their families have access to basic social, familial, and community necessities from a human's rights perspective.

4c (Code:) (Expenses \$ 10,600 including grants of \$ 10,600) (Revenue \$ 14,600)

The Foundation supports programs and efforts to ensure that every child has access to a quality education and that the teachers have the resources they need to provide such an education. During the year, the Foundation supported the following educational entities: (a) Abbie's School, a home school cooperative with 30 children in Culebra. The Foundation provided scholarships to students who who would otherwise not be able to attend. We also provided an electric whiteboard and related equipment to provide teachers and students a tool for teaching and learning, as well as providing the experience of working with this type of technology. (b) Ecologic School is the public school for Culebra with 150 children from Kindergarten to 12th grade. The Foundation has supported the awards program for graduating students. The Foundation has also been supporting the recovery and resiliency of the students and teachers. Paint and supplies were provided, or an art program for the students developed by the University of PR. The teachers participated in a program to build emotional intelligence, positive thinking and resilience provided by a well-known psychiatrist. The program is now being expanded to the parents of the students. (c) Asociación Educativas, a daycare center, caring for 30 children from 2 years old until they are ready for kindergarten. The Foundation provided a generator to allow the center to be fully operational.
