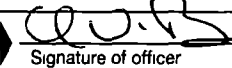

Part 1, Question #8 Other Revenue: \$5,435. The revenue recorded as "Other" is associated with a small tuition requirement for students participating in the Aurora Youth 4 Success (AY4S) program, which is a 3 week program offered to low income high school students in Aurora, Colorado. The program offers courses in Computer skills, Cosmetology, Automotive Tech, and Culinary Arts.

Part 1, Question #10, Grants and similar paid: -\$27,500. This amount represents the amount that was paid out to 22 non-profits in the state of Colorado as beneficiaries to the funds raised and distributed through the Santa Claus Pub Crawl activities. These donations were paid out in amounts between \$250 and \$3,000 to various organizations such as Mile High Early Learning Center, Samaritan House, and Rocky Mountain Downs Syndrome organization.

Part 1, Question #16, Other Expenses: -\$8,666. The largest amount of this other expense was (\$3,596) paid to feed the more than 100 students participating in the AY4S program. The next largest expense was (\$1,837) for D&O and general liability insurance, followed by (\$1,501) for credit card processing and bank fees, (\$753) for website development, maintenance, and (\$979) for various office supplies and other administrative costs associated with the programs.
