They received a Form 1099 for funds received as a missionaries. In addition, they pay a 5 percent fee to WMT on funds received on their

behalf, to cover postage, supplies, etc. These fees amounted to \$1,492 00 for 2017

Also, Frankie Crabtree is a Director and the Treasurer of the Board of WMT and she received no compensation serving in these capacities

Her services were retained for monthly bookkeeping and professional advice, as noted in Board meeting minutes.

She was paid \$5,600 in 2017 and received a form 1099 for that amount
