The Black Male Achievement Conference is an annual conference attended by a variety of people and groups. Conference is paid for thru donations to cover speakers & their expenses, space rental, food, equipment and program supplies.

Event Food- Other programming offered by BMU such as Hungary Man Club, No Murders In May. Food is provided for these events.

Line of Credit-This is a revolving loan available through Nebraska Enterprise Fund. Funds are available to small business to cover cash flow.

BMU generally pays it off within the first year of borrowing from the fund.

Training-Classes are provided through Introduction to the Trades. Funds are used to pay vendors that conduct the training.

Travel-BMU rents a vehicle from time to time to transport students to various sites.
