Together we take direct, immediate action to prevent the extinction of Tompotika's endangered wildlife and the destruction of its native rainforests and rich coral reefs. At the same time, we work side-by-side to promote a deeper appreciation for nature and to create lifestyles and practices that sustain the lands and waters in which our communities are rooted.

Festival Maleo and Sea Turtle celebration held in six local villages. It's a sort of traveling circus, this year themed on Dr. Seuss' The Lorax. In addition to plays with costumes and music, kids and adult activities are scheduled. Entire villages turn out and come away with a sense of the importance of their local flora and fauna. That truly inspires the need to conserve what they have. Jackoustik, a contest created in memory of AITo board member, Jack Barbash, attracted local soloists, small bands, mostly teens and young adults. Their charge was to create and perform an original piece of music, with a conservation theme. Winners in each of two Tompotika districts received cash prizes and a new guitar. AITo continued the Book project, providing kids books to local school libraries, in response for a request for more reading materials in Indonesian language. The books are mostly published in English, with Bahasa translation taped in, so each language can be seen. AITo has continued its Maleo Conservation Awareness Campaign in the schools. We have added field trips for middle and high school students. They can not only hear about their iconic bird, but now see them in their nesting grounds. The Awareness program has been expanded to include anoa and babirusa, also critically endangered species in the area. Collaborating with two other local organizations working in remote areas of Sulawesi and working with ex-hunters whose reputations give them the credibility to say it's not just the animals that are facing extinction, but hunting must now go extinct. Hatching numbers of maleos and turtles continue to increase. Awareness of healthy forest needs is increasing.
