ADVOCACY Since 2010, Joyful Heart has made the elimination of the backlog of hundreds of thousands of untested rape kits in the United States a top priority. We work in partnership at the federal, state and local levels, and with legislators, advocates, law enforcements, and survivors to bring attention, funding, and reforms to improve the criminal justice response to sexual assault. Through several strategic advocacy and education campaigns we are working to enact comprehensive rape kit reform legislation and survivor-centered policies, as well as expand the national dialogue about rape kit testing through increased public awareness. In 2017 we kicked off a multiyear, nationwide advocacy campaign to pass rape kit reform laws in all 50 states. In 2017, 77 pieces of rape kit reform legislation were introduced in 34 states. Of these, Joyful Heart successfully advocated to pass 18 laws and 4 resolutions in 19 states, expanding access to justice for the estimated 67,000 survivors in those states whose rape kits have languished untested. We submitted testimony in four states and 23 letters in support of rape kit reform legislation in 11 states and Puerto Rico. Through The Accountability Project, we seek to uncover information about the number of backlogged kits and rape kit handling policies in jurisdictions around the country. With our pro bono partner Goodwin LLP, we have issued public records requests to law enforcement agencies and crime labs in 49 jurisdictions. As of December 31, 2017 we have uncovered nearly 39,000 untested rape kits at 41 agencies and brought to light the lack of consistent policies and procedures for the handling of rape kits. Joyful Heart engages the general public in ending the backlog, using media coverage, our website, and social media platforms for public education and grassroots advocacy efforts. We are leading the social action campaign for the HBO documentary film, I AM EVIDENCE, produced by our Founder & President, Mariska Hargitay, which premiered at the Tribeca Film Festival in April. From May 1 to December 31, I AM EVIDENCE was screened in 24 states, Washington, D C , and Canada, and all or part of the film was seen by more than 10,000 people at film festivals, partner screenings, and community events.

HEALINGOur healing program seeks to transform the field to adopt a holistic approach to healing and wellness for both survivors and the professionals that support them, while promoting the belief that it is possible to not only survive trauma, but also to thrive and reclaim joy. Since 2013, we have been engaged in a multiyear research project with Dr. Mary Ann Dutton, a renowned professor of psychiatry at Georgetown University, to evaluate the effectiveness of our survivor retreat program in reducing stress related to trauma and improving well-being. The goal of this evaluation is to create a survivor-centric, holistic approach that can be offered alongside other methods of trauma treatment. In April 2017, the research team completed the last of the data collection for all the retreats, culminating the evaluation phase of the retreat research project. The final results will be released in early 2019.

EDUCATION Through large-scale, high-impact public awareness and education campaigns, community events, digital and social media, our blog and web content, media advocacy, research, and influencing storylines on television and in film, Joyful Heart works to raise visibility and elevate the conversation about sexual assault, domestic violence, and child abuse to change attitudes, break the silence, lessen the stigma and shame, engage key influencers, and inspire collective and individual accountability in our society. From January 1 through December 31, 2017 Joyful Heart was mentioned in 2,447 news stories (internet, print, and broadcast), which have an aggregate readership of more than 6.2 billion impressions and amounting to an advertising equivalency of 11.5 million. We presented at 112 events from school assemblies and community gatherings to college campuses, to film screenings and major national conferences reaching more than 19,000 people across the country. In October, our ENOUGH PSA campaign marked its one-year anniversary. The spots aired more than 80,200 times on 863 stations and the donated ad value amounted to \$83 million. We also launched a new PSA campaign, #IWILLSPEAKUP, in partnership with A Call To Men. Viacom aired the spots across their networks and provided pro-bono billboard placement in Times Square which receives an estimated 300,000 daily visitors from November 6 through December 31.
