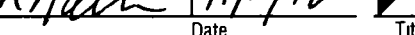

2. Copy of your Internal Revenue Service letter evidencing tax exemption pursuant to Section 501(c)(3) of the Internal Revenue Code and also advising that you are not a private foundation as defined in Section 509(a);
3. Date organization began;
4. Name of person in charge of organization;
5. Purpose of request and use of funds;
6. Will this request be an ongoing request; and
7. Any other data that you think pertinent.

It is not necessary that all of the above be furnished, but the more information supplied, the more helpful it will be in our decision making.

You will be advised of our decision shortly after our next meeting.
