Due to their concern, a licensed CPA was added on the Board to serve as the new Treasurer. It was discovered in September, 2017 that a Board member, who had been serving as a volunteer bookkeeper, had been embezzling money from Crisis Pregnancy Outreach. The volunteer Board member was immediately dismissed from the organization and no longer is affiliated with or has direct access to the organization. A form 3949-A was filed to report the embezzlement in the combined amount of \$64,471 for the years 2013, 2014, 2015 and 2016. A form 1099 was sent to the offender covering embezzled funds in the amount of \$25,976 in 2017. The Board has now hired an outside, independent bookkeeper and has changed to a different CPA firm to audit the organization's books and prepare the form 990 and supporting schedules. The organization researched and reviewed best financial practices and has implemented the appropriate financial practices to help mitigate risk. Additionally, the organization has made changes to the requirements for Board membership and the process for reviewing Board members on a periodic basis. The organization investigated, discovered, took corrective action, and implemented safeguards all in approximately 9 months time. The organization was prudent and diligent in their process and is confident in its ability to be financially stable going forward.
