ALL OF THE THESE PARTNERSHIPS ARE BRINGING NEW DONORS AND VOLUNTEERS TO HUNDREDS OF OUR NGO PARTNERS. WE ARE CONSISTENTLY PIONEERING NEW INNOVATIVE WAYS TO HELP THE WORLD, SUCH AS MEDIAGIVES. MEDIAGIVES IS WHERE WE PARTNER WITH MEDIA ORGANIZATIONS TO INCREASE GIVING AND VOLUNTEERING. CHRISTIAN SCIENCE MONITOR IS ONE OF OUR TOP MEDIAGIVES PARTNERS THROUGH THEIR "PEOPLE MAKING A DIFFERENCE" ARTICLES. WE ALSO WORK WITH OTHER ORGANIZATIONS, HELPING THEM PROMOTE AND FACILITATE GIVING THROUGH PUBLIC SPEAKING EVENTS.
