Furthermore, Mr. Roberts does not have personal knowledge regarding many of the questions raised in this return, necessitating responses based upon debtor's prior year tax return and what appears reasonable under the circumstances. The return was prepared on the limited available information and is unable to verify the accuracy of the information reported on the return.</p>
