HEALTH PROGRAMS COMMUNITY HEALTH SERVICES (CHS) PARTNERS WITH FAMILIES AND INDIVIDUALS TO CREATE CLEAR MOVEMENT TOWARD BETTER HEALTH AND QUALITY OF LIFE. CHS OPERATES A FAMILY MEDICINE CLINIC AND PROVIDES HIGH-QUALITY PRIMARY, PREVENTIVE ADULT AND PEDIATRIC, CHRONIC AND NON-EMERGENCY ACUTE CARE TO APPROXIMATELY 1,300 UNINSURED NEIGHBORS, AMOUNTING TO OVER 2,500 TOTAL OFFICE VISIT ENCOUNTERS IN 2017. ADDITIONALLY, CHS WORKS HARD TO SUPPORT PATIENTS SELF-MANAGE CHRONIC DISEASES, WITH A SPECIAL EMPHASIS ON DIABETES. CHS LEVERAGES SIGNIFICANT COMMITMENTS OF ADDITIONAL RESOURCES THROUGH COLLABORATIVE PARTNERSHIPS WITH BAYLOR HEALTH CARE SYSTEM, INC. AND ITS EMPLOYED HEALTH TEXAS PHYSICIAN NETWORK. CHS FILLS OVER 4,000 PRESCRIPTIONS FOR NEIGHBORS WHO COULD NOT OTHERWISE AFFORD MEDICATION AND WITH OVER 300 MEDICATION MANAGEMENT CLINIC VISIT SESSIONS WITH PATIENTS. AS AN EXTENSION OF THE CHS CLINIC, SATELLITE CLINICS ARE OPERATED AT CITY SQUARE HOUSING SITES. CITY SQUARE'S COMMUNITY HEALTH NURSE HELPS NAVIGATE UNINSURED INDIVIDUALS LIVING IN CITY SQUARE HOUSING PROGRAMS TO THE SATELLITE CLINICS AS WELL AS PROVIDE HEALTHY LIFESTYLE CLASSES THAT EMPHASIZE NUTRITION, PHYSICAL ACTIVITY AND WELLNESS COMPONENTS. COMMUNITY HEALTH TRANSPORTATION PROGRAM (CHTP) WORKS TO ADDRESS SOCIAL DETERMINANTS OF HEALTH BY REMOVING TRANSPORTATION BARRIERS THAT PATIENTS OFTEN FACE WHEN TRYING TO ACCESS HEALTH CARE. THE CHTP TEAM DRIVES UNINSURED PATIENTS TO THEIR MEDICAL APPOINTMENTS ACROSS DALLAS COUNTY. IN 2017, THE CHTP SUCCESSFULLY COMPLETED OVER 1,300 TRANSPORTATION REQUESTS FOR MEDICAL APPOINTMENTS.
