

HELP is dedicated to ending the pandemic of AIDS in Texas and conducts prevention programming to that end; including HIV testing condom distribution, education and services related to Pre-Exposure Prophylaxis

Programming related to grant received from Texas Department of State Health Services to increase uptake of extra-genital screenign for gonorrhea and chlamydia in targeted populations. Activities included hosting annual STIs in Teens and Young Adults conference with TCU, distribution of 3,279 educational materials distributed and recruiting 87 members for Tarrant County STI coalition.

4b (Code:) (Expenses \$ 343010 including grants of \$) (Revenue \$)

Programming related to grant received from the Texas Department of State Health Services for HIV testing, condom distribution, and community mobilization to end HIV. A total of 936 HIV tests were conducted. All newly diagnoses individuals were successfully linked with HIV primary care services. 94,392 free condoms distributed to high risk individuals, 13,938 individual contacts were made to educate at-risk populations about HIV and engage them in combatting HIV. 81 collaborators were recruited to serve on Tarrant County HIV Community Mobilization Committee.

HELP began a clinic for HIV Pre-Exposure Prophylaxis for individuals at high risk of acquiring HIV. Patients at clinic receive all services free of charge. A total of 127 individuals were successfully engaged in care. As a result of the program, more than \$2,000,000 in medications were received for free by program participants.
