The disbursed grants were sent exclusively for charitable or education purposes as defined under Internal Revenue Code 501 (c) 3. Grant funding deployed to Alfanar is used for general purposes and operations that further Alfanar's venture philanthropy work in Egypt and Lebanon.

One of the grants approved on February 9th, for \$27,815 was restricted to Alfanar's work amongst Syrian refugees. The other two grants totalling \$227,000 were generally for operations that further Alfanar's venture philanthropy work in Egypt and Lebanon.

As mentioned above, all of Alfanar, Inc., US's grants were sent to the UK in 2017. The total of \$254,815 was governed by the aforementioned three grant agreements between Alfanar, Inc., US and Alfanar which state that 'Grant funding received from Alfanar, Inc., US under the terms of this agreement will be deployed to Alfanar's general purposes and operations. The grant aims to support and bolster Alfanar's venture philanthropy work throughout the Arab region.'
