After identifying the issue, matter or transaction with respect to which a conflict exists, an Executive Committee member with a conflict shall withdraw from any further involvement in that issue, matter or transaction unless a majority of the disinterested Executive Committee members shall determine that the conflict is (i) immaterial or not adverse to the interests of the American Society of Emergency Radiology or (ii) the benefits of allowing the person with the conflict to participate in the discussion or consideration, but not the final decision, outweigh the dangers, in which case the person may participate in the discussion, study or consideration of the issue, matter or transaction, but not the final discussion or decision. It is the duty of each Executive Committee member to disclose any conflict of interest he or she is aware of to the Executive Committee. New Executive Committee members will be given a copy of this policy and specifically asked to read it. Each Executive Committee member will be asked to complete a Conflict of Interest Policy Disclosure Statement upon his or her appointment or reappointment to the Executive Committee.
