RADIO PROGRAM Every Village continued the operations of our 3 radio stations beginning the year with 18 total staff members. We brought a professional radio coach to South Sudan to provide technical training in each of our studios. We also distributed 33,100 solar-powered radios which represents the most we have ever brought to South Sudan in one calendar year. This brought our total distributed all-time to 85,100. These radios are fixed-tuned to our stations and continue to significantly broaden the accessibility and popularity of our stations. We held our first annual radio listener support campaign at our station in Aweil and over two weeks we received 811 pastors bringing contributions from 24,507 church members of over 1.3 million South Sudanese Pounds (about \$7,500) which covers six months of operating expenses.
