FREE INDIVIDUAL MENTAL HEALTH COUNSELING IS OFFERED WEEKLY AT THE CLINIC IN SPANISH AND ENGLISH FOR PEOPLE NEEDING FURTHER SUPPORT AS WELL AS WEEKLY START AGAIN NOT OVER GRIEF AND LOSS CLASSES. A HEALTHY HEARTS KIDS CLUB DESIGNED AND LEAD BY SALUD TEENS OFFERS A WEEKLY KID-FRIENDLY CURRICULUM ADDRESSING HEALTHY EATING AND ACTIVE LIVING AND EMOTIONAL WELL-BEING THAT MIRRORS WHAT THEIR PARENTS ARE LEARNING IN THE CORAZONES SANOS (HEALTHY HEARTS) PROGRAM.
