The Midwife Program in Matagalpa, Nicaragua

Expenses: \$ 5,339

The Midwife Program provides ongoing training and support to midwives and women's community health workers who have completed the Skills to Save Lives program. During the first nine months of 2017, fifteen (15) participants received additional training in alternatives to violence with additional classes scheduled for the final three months of the year. Forty-four (44) participants from sixteen (16) communities completed an internship program at a health center or hospital. In addition, twenty-two (22) new women's community health workers were trained using the original curriculum during 2017. Programs continue to be developed based on needs of the women and families in the communities where these midwives are located. These health workers use the education they receive to plan programs in their home communities. From January to August 2017, health workers and their mentors provided over 200 presentations to environment and other topics. Fifteen (15) women or children were identified as victims of violence by the health promoters and were provided medical, psychological, and legal assistance as well as help to address housing, employment and other needs.

WEN is partnering with the Indonesian organization IKAWANGI which is an established CSO in Indonesia. Projects include building a lending library for village children, a school fee assistance program, trainings for women in home industry-style empowerment projects, as well as addressing the miner's health and safety needs. The project affects a community of about 400 miners and their families.
