Project Child SuccessOver 100 organizations and individuals in Pierce County have come together to achieve the vision that all children thrive in nurturing relationships and environments. F5F is the non-profit organization that provides staffing, leadership, communication, and data support to PCS. Work includes leading networking opportunities for community partners, planning shared professional development events and learning opportunities, organizing research and data projects, and facilitating advocacy and policy development. This program focused on engaging families through a simple grass roots approach called Child Centered Community Conversations. The goal was to collect qualitative data from parents and families, about their vision for a child centered community. A family and community organizer hosted small group conversations with parents or those in parenting roles (5-15 people). In 2017, ten conversations took place with approximately 75 people throughout Pierce County. Participants were from diverse backgrounds including a foster parent support group, private school families, members of a local church, members of a community center, families from the Rescue Mission, and in various private family homes. During the meetings participants were asked one simple question, If you were scooped up and plopped into the most child centered community in the universe, what would you see? What would you notice? The facilitator took notes and captures all the ideas. Following the meeting, all of the comments were published into a data dashboard on the PCS website. Comments were kept anonymous to protect family identities. If families chose, they were also added to a PCS parenting e-newsletter that is sent monthly, so they can continue to be engaged with the ongoing work of PCS. The data dashboard is regularly reviewed by PCS action teams to help guide on the ground activities.

Building Community Protective FactorsThe objective of this program was to increase knowledge of Adverse Childhood Experiences (ACEs) and build up the Strengthening Families Five Protective Factors throughout Pierce County. The protective factors include social emotional competence of children, knowledge of child development, social connections, parental resilience, and concrete support. The target audiences was parents and caregivers, early learning professionals, and community based organizations. Project activities included (1) a training for 200 plus parents and caregivers to raise awareness of ACEs and tools for building the Protective factors, (2) a Protective Factor training for 60 home-visiting professionals to learn practical skills for engaging with children and families who have experienced trauma, (3) a community screening and panel discussions of the film Paper Tigers.
