We are currently working with groups of students, their parents and community members in Sunflower County MS. We engaged 95 students in 20 workshops during the year. These workshops included "Infinite Possibilities", Education Day, Health Day, Healthy Relationships Day, Career Day, and Wisdom Coaching for Kids Day. We engaged in a 1 day meeting in February in participation for the student field trip to Orlando, Florida for 93 students. We executed three days of training in Orlando, including leadership, relationship building, dressing for success, communications skills, and afternoon fun in the parks. We executed a graduation ceremony for the students. We hosted alumni meetings and a field trip for the alumni to Seville, TN in June, 2017 for 56 alumni students and chaperones. We engaged 22 parents in 10 evening workshops and covered the following topics - civic education, the law of attraction, mindfulness, and ten healthy ways to achieve success.

**Part III, Line 1** Our mission is to be a change agent in the transformation of poor and low income communities from a perceived place of poverty, low skills, and despair to a place of prosperity, abundant skills, and hope. The Dollars For Your Thoughts program engaged 88 Sunflower County middle and high school students in 5 weekly training sessions for 5 hours per week and in dialogue and conversation about their present circumstances and their outlook for the future. These dialogues included discussions about health, nutrition, education, race, social interactions, and healthy relationships. The conversations entailed demonstrating how our thoughts and feelings about our circumstances and how our outlook on life determines what our future will look like. The training classes also help students to align their unique strengths, talents, gifts, and greatest passions with a clear vision for the future. The intention of this project is to inspire youth to take purposeful action in the present so that they can create a life of great fulfillment for the future. One of our goals is for the students completing the program to have a positive impact on their peers and on the Mississippi Delta. We also engaged 22 adult students and parents in a 10 week weekly program to teach them the some of the same topics that we teach the students. We also teach them mindfulness, parenting skills, and steps to achieve success for both themselves and their children. This year we provided nutritious food from the food pantry to approximately 350 families per month. We provided field trips to expose the students to life outside the Mississippi Delta.
