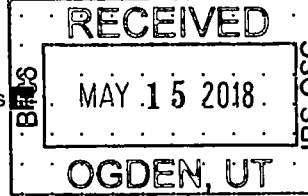

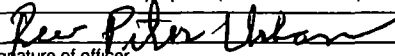

Miguel Pro Mission operates to bring hope to poor people in northern Mexico in the border cities of Ciudad Juarez and Anapra. Services are provided by several distinct non-profit organizations and religious individuals, including Las Hormigas Comunidad, Las Hermanas Tonantzín, Madre Marina, Sister Petra, and San Alphonso Mission. Educational support is the most important gift to the communities, providing scholarships for over 125 students, kindergarten through college. Education is the key to lifting people out of poverty. Counseling support is also provided to children and women who have witnessed or experienced violence in their lives. Grants are also provided for support services to communities for daycare for both children and elderly, healthcare clinics, and therapy help. Miguel Pro Mission has also provided funds for the construction of a new chapel near Anapra in 2017 and continues to help with construction projects to build indoor bathrooms (including composting toilets), repair roofs, build animal enclosures for chickens, goats, etc., and build greenhouses and other basic facilities. An adobe brick machine, previously purchased by Miguel Pro Mission, reduces the cost of building projects in the communities.

Line 28A: Grant of \$3,800 to Las Hormigas Comunidad - Las Hormigas Comunidad is a small group of former nuns that provide therapy to children and women who have witnessed or experienced violence in their lives. It also promotes education and community service

projects. This 2017 grant was to help with the work of Las Hormigas Comunidad.

Line 29A: Grants of \$12,000 to Madre Marina - This grant provides scholarships for 100 plus students, kindergarten through college, to support their ongoing education. Madre Marina facilitates this project.

Line 30A: Grants of \$65,190 to the Tonantzln Sisters: These grants support a daycare center that provides safety, early childhood education and love to children of parents who work 10-12 hours a day. They support an associated Montessori school (grades kindergarten through 8th grade) for 100 plus low income children. They also provide counseling and health services for children and adults living in a city of daily violence. In 2017, \$26,500 of the total grant monies was directed to construction projects (homes for families, roof repair of existent homes, and a community garden).
