Bozeman Health Medical Group employs physicians under the Bozeman Health system umbrella. This group of providers compassionately serves the patients of Bozeman Health Deaconess Hospital, Big Sky Medical Center and Bozeman Health Urgent Care.

## **Form 990, Part III, Line 4b:**

In efforts to reach our community and surrounding area in multiple facets of healthcare, the Bozeman Health system operates additional healthcare facilities which allows more access and levels of care Big Sky Medical Center had 42 admissions, 34 surgeries and saw over 3,100 patients in the Emergency Room and over 4,100 in the clinic in 2017. The net revenue yield on these operations was only 55.6%, or \$768 per equivalent ER visit. With challenging core staffing and related costs, the operating expense (excluding interest, taxes and depreciation) was \$1,491 per equivalent ER visit. This resulted in a \$5.5M operating loss for the year. Bozeman Health is committed to providing access and patient care to the Big Sky community in spite of the financial operational challenges the facility continues to face. Bozeman Health also continues to operate our Main Street Urgent Care as an outpatient healthcare access point. With a 56% yield on \$5M of patient charges and operating costs of \$4.2M, the Urgent Care netted a loss of (\$1.4M) in 2017.

Bozeman Health serves as the parent company of the Bozeman Health system. As the corporate parent, management, general and administrative services are centralized here and provided to the operating units caring for our patients. These administrative and support services aim to optimize executive, organizational and financial responsibilities to allow the health system to continue to grow and serve the population. In this past year, Bozeman Health had 18,399 inpatient days, 187,297 outpatient hospital visits, 243,039 outpatient clinic visits, 34,670 emergency room visits and performed 8,985 surgeries.

About 16.8% of Bozeman Health inpatients were insured under Medicaid in 2017. Bozeman Health's tri-county service area houses five hospitals, of which three are critical access hospitals (CAH): Bozeman Health Deaconess Hospital (Bozeman, MT), Bozeman Health Big Sky Medical Center (Big Sky, MT), Livingston HealthCare-CAH (Livingston, MT), Madison Valley Medical Center-CAH (Ennis, MT), and Ruby Valley Hospital-CAH (Sheridan, MT).
