The governing body of Holy Spirit Memorial Foundation consists of 10 members. The 10 members include the Rector of Holy Spirit Parish,
three members appointed by the Rector, three members appointed by the Vestry of Holy Spirit Parish, and three members elected by the
Parish at the Annual Meeting of Holy Spirit Parish which is held every January. The Board members are all volunteers and receive no
compensation. The Treasurer is a volunteer who has no voting rights and has no authority over the members or decisions made by the
members. Meetings are held quarterly. A budget determining the cash amount of support to the affiliated church, Holy Spirit Parish is
based on the earnings of the investments and is approved by the Holy Spirit Memorial Foundation board. The checks written to the Holy
Spirit Parish are signed by two authorized persons, two members of the Foundation. All minutes of the Foundation meetings are available
at the Holy Spirit Parish office.

The monthly financial statements are prepared monthly and reviewed by voting board members and approved on a quarterly basis.
The annual financial statements are reviewed by an independent auditor and a certificate issued. The statements are presented at the Annual
Meeting held in January for all members of Holy Spirit Parish. The Form 990 is available to the public at the Holy Spirit Parish office.

Schedule D Disclosure

The endowment funds interest only are used for education, travel to the Holy Land, music and support of Holy Spirit Parish where needed.
The by-laws and financial statements are available to the public at the Holy Spirit Parish Church office. The financial statements are prepared
monthly and presented quarterly at the Memorial Board meetings, and reviewed by an independent auditor annually. The Holy Spirit Memorial
Foundation Annual Report is presented to every member of Holy Spirit Parish attending the Annual Meeting and copies of the Annual Report
and Form 990 are available at the Holy Spirit office.
