Montana Conservation Voters, Inc.'s primary exempt purpose is to educate and activate voters to be vital and effective participants in Montana's democratic process, to protect air and water quality, public health, fish and wildlife and open space. MCV informs the public about the votes and actions of local, state and federal elected officials pertaining to conservation and environmental issues, and encourages their involvement in government.

Outreach and Community Organizing: Over the summer of 2017, MCV launched a door to door fundraising canvass. We knocked 16,761 doors, secured 2,504 petition signatures of which 1,734 had good e-mails, and raised \$60,450 renewing 414 members and capturing 1,120 new members. This campaign was focused on transitioning from dirty coal and moving Montana toward a cleaner more renewable energy future based on rooftop solar, backyard wind and large-scale wind farms. The campaign captured comments to Montana's U.S. Senators urging them to oppose President Trump's budget cutting 31% from EPA's budget and slashing the Land and Water Conservation Fund and to restore funding for EPA's climate change programs.

MCV's four chapters, Yellowstone County, Gallatin-Park County, Missoula County and Flathead County each convened membership meetings attended by an individual low of 20 members and a high of 80. Chapter boards meet approximately nine times per year.

Energy Blueprint and Public Lands Agenda. Specific areas of work in 2017 included:

- 1) Working with the Bullock Administration to implement the public lands agenda which included the onboarding of a public access specialist within the Department of Natural Resources & Conservation, a new Office of Outdoor Recreation within the Office of the Governor, and restoring the Habitat Montana so it could acquire land to increase access to public lands, streams, and rivers.
- 2) Working with the newly elected 2017 Montana State Legislature to educate them about pending proposals to advance clean, renewable energy and energy efficiency, public lands protection, as well as clean water laws and measures to ensure broad-based citizen participation, while opposing roll backs.
- 3) Opposing proposals to transfer federal lands to the state as well as the dedication of any state funds to study this.
- 4) Continuing work during the 2017-2018 interim legislative period by testifying before the Interim Energy and Telecommunications Interim Committee regarding clean energy policies.
- 5) Coordination of meetings of the Conservation Working Group, a coalition of groups organized to advocate for strong environmental policies post-election and pre-session to establish legislative policy priorities.
- 6) Recruiting and securing appointments of conservation and environmental group leaders to openings on relevant local and statewide boards and commissions.

Accomplishments included lobbying and accountability work at the 2017 legislature to enact proactive, positive conservation policy that included clean energy, public lands, and reducing greenhouse gas emissions. Additional legislative preparation included defensive efforts to defeat legislation that would have rolled back net

metering laws in Montana, eliminated the Board of Environmental Review, increased taxes on electric vehicles and alternative fuels, and prevented public input on renewing the lease for a proposed new coal mine in southeastern Montana. Preparing for these accomplishments were achieved with the support of the Conservation Working Group, comprised of 13 allied organizations.

As it does each year, MCV released the national League of Conservation Voters' Congressional Scorecard in February 2017 with a press release and earned media efforts in the statewide and local press. MCV also completed rigorous social media and digital efforts to disseminate the message to a broad audience.

At the federal level, MCV advocated passage of a funding for the EPA and clean energy programs at DOE as well as range of public lands policies including full funding and permanent reauthorization for the Land and Water Conservation Fund and protection of the Antiquities Act. MCV also continued its work to defend the Clean Air Act and advocate for aggressive carbon reduction goals under the Clean Power Plan. Staff travelled to Washington, DC to lobby Senator Tester and his staff as well as staff for Senator Daines.

In the summer and fall of 2017, MCV chapter leaders and staff prepared non-partisan questionnaires mailed to candidates running for the statewide, legislative, and local offices and invited them to participate at chapter membership meetings. MCV also communicated with members about what was at stake in the 2017 local municipal elections and provided voter information to residents of these communities about the environmental positions of those who responded to questionnaires.
