Montana Conservation Voters Education Fund's primary exempt purpose is to provide research and public education to the members of conservation and environmental organizations in Montana, and other interested Montanans to protect Montana's clean air and water, wildlife, forests and open space. MCVEF seeks a more informed, educated and empowered conservation and environmental community in Montana, who takes part in this state's democratic process.

Conservation Policy Program: At the state level, MCVEF had a robust public policy and public education program related to public education and building support for policies to be pursued by the 2017 Montana State Legislature, including policy accountability and the 2017-2018 Legislative Interim.

Another state priority was to assess the impact of a proposal to transfer federal lands to the state. In addition, we worked with partners to develop a proactive state based public lands agenda. MCVEF provided policy analysis, distributed public information, coordinated media stories, prepared briefing materials and facilitated comments to the legislators and the Administration.

MCVEF provided public policy services, including analysis of state legislative proposals; preparation and distribution of briefing papers; coordination of meetings with allied conservation and environmental groups; and weekly meetings with legislative allies and staff of the Governor's office.

At the federal level, MCVEF coordinated the Climate Action Coalition, working in partnership with the national League of Conservation Voters Education Fund and over a

dozen conservation, public health and fish and wildlife groups. The key focus was to oppose the rollback of EPA's rule to reduce carbon emissions in the United States by 2030. MCVEF worked to educate citizens, local and statewide decision makers on the impacts of climate change and the EPA rule on public health, fish and wildlife and a clean energy future, and to encourage the EPA use its authority to protect public health under the Clean Air Act, including from the negative impact of carbon emissions. MCVEF leaders were part of letters to the editor and guest commentaries.

Community Organizing, Outreach and List Enhancement: Over the summer of 2017, MCV launched a door to door fundraising canvass. We knocked 16,761 doors, secured 2,594 petition signatures of which 1,738 had good e-mails, and raised \$60,450 renewing 414 members and capturing 1,120 new members. This campaign was focused on transitioning from dirty coal and moving Montana toward a cleaner more renewable energy future based on rooftop solar, backyard wind and large-scale wind farms. The campaign captured comments to Montana's U.S. Senators urging them to oppose President Trump's budget cutting 31% from EPA's budget and slashing the Land and Water Conservation Fund and to restore funding for EPA's climate change programs.

Toward the end of the year, we launched a Mobilization Center serving as a field operation consisting of three paid canvasser organizers directed to experiment with the efficacy of "deep canvassing" on land development vs land protection and identify opponents to a mine at the Gateway of the Yellowstone National Park.

The launch of the Mobilization Center was the culmination of work building a

coalition combining MCVEF, the Greater Yellowstone Coalition, Montana Wilderness Association, and Montana Wildlife Federation called the Montana Engagement Partnership (MEP). The MEP is a long-term communications and grassroots strategy designed to leverage popular support for shared values (such as public lands, clean water, wildlife, and rural/ag heritage) to create broad change in Montana that will lead to durable conservation and clean energy policies.

MCVEF also maintained strong non-fiduciary responsible chapter boards directing climate, clean energy and public lands work in Flathead County, Missoula County, Gallatin & Park County, and Yellowstone County. Flathead County's chapter focused on launching a municipal climate action plan, showing of a film "To The Ends Of The Earth" and educate the county on a proposed water bottling plant at the north end of Flathead Lake. Missoula County's Chapter also showed the film "To The Ends Of The Earth", organized dozen's of panels, rallies, and speakers on wildfire, climate change, and public lands. Missoula County and Gallatin County were also educating the public on proposed open space bonds that may be on the 2018 ballots. Yellowstone County was also focused on organizing events around our key topics of education, climate change, renewable energy and protecting our public lands.
