Welcome Baby  
The Welcome Baby Program is an expansion of our "Baby Carriers for Refugees" program. This international effort provides baby carriers, baby beds, diapers, baby bundles of supplies and handmade "Me2You" baby items to refugee families while they navigate the asylum process. Carry the Future volunteers delivered over 4,400 carriers, 2,500 Bundles of Joy, 200 Baby Bed Bundles, and thousands of other items of necessary baby aid. Carry the Future volunteers donated thousands of volunteer hours to this program.

Emergency Response  
CTF's Emergency Response Program was new in 2017. The program focuses on refugee families immediate needs to include food and clothing. Carry the Future volunteers delivered 17,000 winter hats, 4,500 pairs of winter gloves. Dignity items were also provided, purchased in country and delivered to refugees and refugee families. In 2017, CTF delivered nearly 30,000 bags of tea, 500 protein bars, and shipments of fresh fruit and vegetables to refugee families. This program is staffed and operated by volunteers with assistance from an all-volunteer board.

Community Infrastructure  
Carry the Future's Community Infrastructure Program is a new program for 2017. It focuses on building infrastructure to assist families. This program is staffed completely by volunteers with the assistance of an all-volunteer board.
