In July 2017, FIRST Global hosted the inaugural FIRST Global Challenge in Washington, DC. An olympic-style competition, the 2017 games hosted teams from 157 countries, plus several continental teams. Each team is allowed a maximum of 7 student competitors to attend the event with an unlimited number of team members allowed to work on the challenge in their home country in preparation for the event. Under the guidance of volunteer mentors, approximately 1,100 high school students attended the event. In preparation for the 2017 FIRST Global Challenge, over 600 volunteers actively mentored participants. These community-based volunteers range from civic minded high school and college students, to entire university robotics and engineering departments, and provided teams with mechanical, electrical, programming, and strategic advice.
