Hearing the Call supported seven humanitarian trips in 2017. Supplies, equipment and hearing aids were provided in Guatemala, Jordan, Zambia, Mozambique, Ecuador and Turks and Caicos. In all, 651 hearing aids were accurately fit to men, women and children over the course of 2017 in the areas that were served. Hearing the Call also started a new fundraising and awareness campaign by purchasing Syrian refugee children's art that was painted in Jordan. The art will be displayed and sold around the country to give a voice to the refugees that we serve. We help children hear by bringing hearing health care to thier communities, and we bring back their artwork to help their stories be heard.
