The newly established SDHB Pheo-Para Coalition has been operational since January 2017. We set out at the beginning of the year with a number of key objectives and I can report that we have made excellent progress in this regard. The first objective was to successfully launch the SDHB PheoPara Coalition as a 501(c)(3) not-for-profit organization. This was accomplished on schedule.

The second objective was to spread the word about the existence of our organization and to fund, organize and staff the Coalition so that it could begin its work. We finalized the board, established a variety of sub-committees, and started to spread the word by creating and disseminating a number of informational videos which provide background and treatment information on this rare disease.

These videos are designed to help healthcare professionals and patients who have questions about the disease.

The third objective was to have a successful fundraiser and our first annual gala was held on April 20, 2017. Our goal was to try and raise approximately \$300,000 and have more than 250 attendees. Both of these objectives were achieved and we are looking forward to another successful event on April 19th, 2018.

The fourth objective was to support at least two or three good scientific projects which will lead to a better understanding of this orphan disease and ultimately an effective treatment. In October 2017, we approved our first research project and we have two additional worthwhile projects pending. We will provide more details on all of these projects through our website during the course of the year.
