Spur awarded \$10,000 to St. Luke's Wood River Foundation - where Tim Wolff, Spur Board Member is also a current board member. Spur's Board takes care to recuse people from voting where there could be a perceived conflict of interest. These situations are bound to recur given the size of the community in which the 2 organizations operate.
