The organization made huge strides towards its purpose and mission of bringing socially inclusive playgrounds to communities everywhere. During 2017 there were 4 playground projects in development with the following accomplishments: (1) Redwood City, CA - Initiated payment from UnaMesa Association, Magical Bridge Foundation's initial fiscal sponsor, to the City of Redwood City for construction of Magical Bridge Playground at Red Morton Park. Engaged 454 donors and approximately 160 volunteers. (2) Sunnyvale, CA - In July 2017, Magical Bridge Foundation announced the Sunnyvale Magical Bridge project at Fair Oaks Park. Engaged 85 donors and approximately 50 volunteers. (3) Morgan Hill, CA - In August 2017, Magical Bridge Foundation announced the Morgan Hill Magical Bridge project at Community Park. Engaged 131 donors and approximately 50 volunteers. (3) Mountain View, CA - Met and worked to finalize contracts with the city of Mountain View to launch a Mountain View Magical Bridge Playground Project in Mountain View. The project was officially announced in Jan 4th, 2018. In addition, in 2017, the foundation held various programs at the Magical Bridge's inaugural playground in Palo Alto, where an estimated 25,000 people visited the playground each month. Accomplishments included: (1) 2017 "Music is Magic" concert series with 14 concerts at 10K attendees over the whole series. (2) Launched "Team Visual Magic" a group creating playground innovations for the visually impaired. (3) Prototyped and developed "Autistic Hideaway Huts" which will be placed in future Magical Bridge Playgrounds. (4) Announced Magical Bridge Playground featured at Smithsonian Cooper Hewitt's Access and Ability Exhibit. (5) Created first open and closed caption video about Magical Bridge Foundation. Although it is not reflected in the 990, Magical Bridge Foundation initiated from UnaMesa Association, Magical Bridge Foundation initial fiscal sponsor, to the the City of Redwood City for construction of Magical Bridge Playground at Red Morton Park. In 2017, Magical Bridge Foundation was under contract to build and fundraise for playground projects in Sunnyvale, CA and Morgan Hill, CA. An additional contract in partnership with UnaMesa Association was signed in 2016, but included activity in 2017. As part of these contracts, Magical Bridge Foundation supported applications by the applicable city to the County of Santa Clara All-Inclusive Playground Grant Progra (AIPG). Through this partnership, Magical Bridge playground projects secured \$2M of AIPG funding for the city of Morgan Hill and \$1.7M for the city of Sunnyvale. These funds were paid directly to the cities and were not received by Magical Bridge Foundation. Although Magical Bridge supported the cities' application for government funding for the playground projects, Magical Bridge did not directly receive any government grants in 2017.
