A grant for \$5000 was sent to Shyira Diocese in Rwanda as a donation from Rocky Mountain Diocese in Colorado to assist with recovery from landslides. A grant for \$2500 was sent to Gasabo Diocese in Rwanda from Anglican Diocese of the South in the United States for the purpose of assisting with church construction for a sister parish relationship.

Additionally, separate donations of \$600 for Byumba Diocese and \$2,228 for Cyangugu Diocese in Rwanda were sent to assist with secondary school and seminary fees for needy students being assisted by a scholarship fund in those dioceses. These grants represent an additional \$10,328 in program grants provided.
