This space is used by members for their own independent research projects as well as by members of the public who wish to participate in community projects that help to engage locals in citizen science. SoundBio currently has over five independent research projects underway as well as two community projects with meeting attendance between 2 and 10 people each session.

Tabling Events - SoundBios volunteers and members are passionate about bringing science education to the community, so frequently bring science outreach activities to the Greater Seattle area by attending many tabling events. In 2017, SoundBio attended nearly 15 tabling events with each event reaching anywhere from 30 to a couple hundred participants.
