TAXPAYER IS LOCATED IN AN AREA THAT WAS SEVERELY IMPACTED BY A FEDERALLY DECLARED NATURAL DISASTER (HURRICANE HARVEY) AND ITS LEADERSHIP WAS SEVERELY IMPACTED. AS A RESULT, DURING EARLY 2018 THOSE IMPACTED IN LEADERSHIP COMMUNICATED WITH ANOTHER MEMBER OF LEADERSHIP THAT THEY WOULD LIKE FOR HIM TO TAKE OVER THE RESPONSIBILITY FOR THE COMPANY'S ACCOUNTING AND TAX FILING FUNCTIONS.
