Explanation

PREVIOUS TREASURER PASSED AWAY 2018 AND HAD NOT FILED THE RETURN. THIS WAS UNKNOWN UNTIL THE NEW TREASURER WAS ELECTED. THE NEW TREASURER DID NOT GET ALL OF THE PAPERWORK UNTIL RECENTLY AND FILED AS SOON AS WAS POSSIBLE. THE RETURN DID NOT INCLUDE A COMPLETED SCH A DUE TO OVERSIGHT BY PREPARER NOT RECOGNIZING THIS NEW CHARITY HAD NOT BEEN ESTABLISHED FOR 5 YEARS. YOUR CONSIDERATION OF THE EXPLANATION WOULD BE GREATLY APPRECIATED.
