approximately 100 per bootcamp, with 12 bootcamps planned per year. Lunch and Learns are a
series of panel discussions, held once a month, open to the public, on topics such as Racism and
Mental Health, closing opportunity gaps for students, diversifying the teacher work force, and
intersectionality. Each session has about 60 people in attendance and is live-streamed on the
internet.
