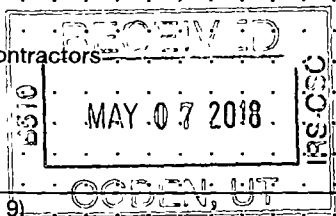

Mission: To inspire and connect students from underserved communities to skills-based educational pathways and high-demand employment
opportunities that will provide a path to economic mobility.

2017 was the first operating year of the organization. We served 600 students through Career Test Drives and Near-Peer Advising during this
year and built up capacity to serve many more students in the future

Services Provided:

Career Test Drives - hands-on simulations of high-demand careers in a mobile, Career Fair-like environment. Students "try on" careers to assess
their personal interests through 20 minute challenges.

Near-Peer Advising - SMS based support and guidance for students after high school graduation. Advising is specific to high-demand employment
and educational opportunities and is done through trained college students.

Programmatic Expenses:

Career Test Drives - includes materials and supplies, transportation to/from Fairs, insurance, hourly operator costs, research and
development of new Career Test Drives with industry sponsors, technology, 38% of Executive Director time

Near-Peer Advising - includes technology used in advising, advisor training and material costs, school communications and partnership
development, insurance, 27% of Executive Director time
