28	IntroductionDuring the first year of operations the Ron McBride Foundation was honored to be supported by a caste of volunteers to carry out its mission Over the calendar year several events and campaigns were conducted Among these were two major events which required significant planning time as well as talented volunteers Throughout the year our Board of Directors were engaged ion a variety of efforts t raise awareness of the foundation, support the programs and campaigns organized by the Executive Director and Administrative Assistant The work of the Board of Directors was led by the Founder (Ron McBride) who provide 261 plus chronicled hours in meetings, speeches, and fund raising His efforts are calculated at \$28,710 00 of valued service to the organization The Board of Directors was led by President Jesse Boone, MBA who also served as Treasurer Jesse spent more than 290 hours of service and his efforts are calculated at \$21,808 00 The Executive Director was Dr David M Compton who served to coordinate all events and campaigns He provided 579 hours of service valued at \$50,419 32 Mrs Sara Parson served as the Executive Assistant and provided endless hours for the foundation She spent more than 530 hours in her efforts to support the mission of the foundation Her efforts are calculated at \$20,299 00 Other volunteers who served to carry out the mission of the Foundation included the Event Coordinator (Kristine Schicker), web/social media Coordinator (Tyler Parson), and a list of over 50 event volunteers who were instrumental in successfully managing the two major events (Love You Man Golf Tournament and the MAFU golf event) These volunteers were not compensated and yet provided nearly \$20,000 of their time and talent to the foundation In summary, the Ron McBride Foundation received the professional and volunteer services of many individuals to commence its first year of operations The total of their services equals or exceeds \$127,950 00 of effort in behalf of the stated mission It should be noted that Dr Compton and Mrs Parson were provided a small stipend of \$1,500 00 each for their services (Grants \$ 11,361)		28a	62,020
