The program provides transportation, outreach services, meals, and recreational programs to the community's elderly citizens. The program serves more than 21,000 senior citizens in Meridian, Idaho. Seniors are transported for medical care, weekly shopping, and to the Center for meals and activities. The program provides meals at the Center and to seniors in their homes. During 2017 the program provided approximately 14,400 meals and transported seniors with approximately 11,400 miles traveled.
