THIS INCLUDES TRADITIONAL COMMUNICATIONS WORK SUCH AS MEDIA OUTREACH, CONTENT CREATION, RESEARCH AND STRATEGY DEVELOPMENT. CLIMATE AND ENERGY REMAINS THE LARGEST ISSUE SECTOR, COMPRISING ABOUT HALF OF THE BUDGET. HOWEVER, THE ORGANIZATION CONTINUES TO EXPAND BEYOND ITS TRADITIONAL ENVIRONMENTAL ADVOCACY WORK TO INCLUDE COMMUNITY HEALTH, SOCIAL JUSTICE AND GLOBAL DEVELOPMENT.
