Through its Voters Not Politicians Ballot Committee, CMV initiated a petition drive to qualify a proposed amendment to the Michigan constitution for the November 2018 statewide election. This amendment, if approved by a majority of voters, will replace state laws that allow whichever political party controls the state legislature to adopt partisanly gerrymandered legislative and congressional districts. It will replace it with an independent commission intended to adopt fair and nonpartisan districts following each decennial census. In December 2017, the all-volunteer petition drive completed collection of over 425,000 signatures of registered voters, far exceeding the 315,654 valid signatures required for ballot qualification.
