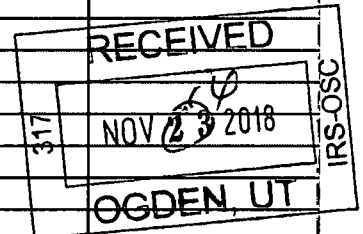

In addition to the activities reported to the IRS on Form 1023, the Bonnie and John Jackson Foundation (the "Foundation"), U/T/A dated January 15, 2016, intends to engage in the following activities:

In addition to the planned direct distributions to economically disadvantaged individuals and families as direct financial assistance for their health, welfare and care as previously reported on the Foundation's Form 1023 (see Part IV, Item 4.a), the Foundation intends to:

1. Make direct distributions to economically disadvantaged individuals, including but not limited to people employed now or in the future at Jacksons Food Stores, Inc., a Nevada corporation, for the purpose of covering all costs associated with extensive dental procedures necessary to maintain good dental health. The approximate size of the initial pool of eligible recipients (i.e., those who have been employed at Jacksons Food Stores, Inc. for longer than eight (8) years) is three hundred forty (340) people. Distributions for extensive dental procedures are available to all such Jacksons Food Stores, Inc. employees or others who qualify, irrespective of any such employee's job performance.
2. Make direct distributions to individuals for the purpose of providing future disaster relief and relief from extreme financial distress to individuals, including but not limited to employees of Jacksons Food Stores, Inc., who are facing extreme financial and medical conditions because of situations beyond their control such as earthquakes, hurricanes and other acts of nature or other financial matters mainly outside of their control. Distributions for disaster or financial relief are available to all such Jacksons Food Stores, Inc. employees or others who qualify, irrespective of any such employee's job performance.

The Foundation intends to begin distributing funds to the individuals described in this section in the near future and thereafter intends to distribute funds periodically.

The Foundation will require an accounting of the expenditures pursuant to any grant to an individual. The Foundation may require copies of documentation, receipts, or make site visits as necessary to supervise grants, and the Foundation will comply with all applicable legal authority including Internal Revenue Code Section 4945.

The Foundation intends generally to monitor its charitable distributions to the individuals described in this section through follow-up accounting procedures. If a misuse of funds is discovered, all reasonable steps, including litigation, will be taken to recover such funds from the recipient. Upon discovery of a misuse of funds, the relationship between the Foundation and the

misuser of funds will be terminated immediately and any such funds remaining payable to the misuser pursuant to the terms of the grant shall be retained by the Foundation.

These activities will be conducted by the trustees of the Foundation. The trustees will meet annually or more frequently to review distributions and information with regard to potential distributee individuals. A committee (the "Distribution Committee") comprised of at least three (3) members (the "Committee Members") shall select, by the majority vote of the Committee Members, select eligible individuals as recipients for distributions from the Foundation, as well as the size of such distributions, and the decision of the Committee Members shall bind the Foundation. Committee Members shall be appointed by the trustees of the Foundation, and may be removed and replaced by the trustees of the Foundation in their sole and absolute discretion. Committee Members may include trustees of the Foundation, employees of Jacksons Food Stores, Inc., or any other persons.

No affiliates or relatives, including spouses or descendants, of any trustee, manager, or substantial contributor of the Foundation, or any other "disqualified persons" (as defined in Internal Revenue Code Section 4946) are eligible to receive any distributions or assistance from the Foundation.
