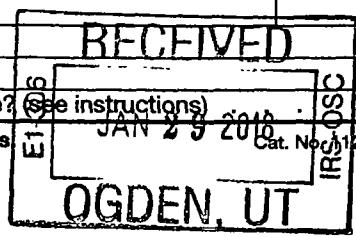

Lever Foundation works with major food companies to encourage and help them to remove the worst forms of animal cruelty from their supply chain. Additionally, Lever works with retailers, consumer packaged goods companies, and other food industry companies to encourage the creation, distribution, and sale of more plant-based or "clean meat" (laboratory grown) meat, egg and dairy products to increase the proportion of non-animal-derived food products consumed by the public. This program will reduce the number of animals subjected to cruelty on intensive factory farms and increase the healthiness, humaneness and sustainability of the food products offered by major food companies.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

Lever Foundation works with school districts and other institutions to encourage and help them to reduce the amount of animal-derived foods they are serving in their institutional food service, and increase the amount of plant-based foods they are offering. This program will reduce the number of animals subjected to cruelty on intensive factory farms and increase the healthiness, humaneness, and sustainability of institutional food service programs.

Lever Foundation provides strategy guidance, thought leadership, consultation, and hands-on assistance to help volunteers, donors, and other charitable organizations with the same mission as the Applicant.
