 In support of the sport of gay rodeo, IGRA sanctioned 10 gay rodeos and associated activities as well as hosting the World Gay Rodeo Finals in Albuquerque, NM. There were 858 competitors in 6,683 entries for these events. IGRA provided support for seven rodeo schools and two rough stock training academies. The IGRA University was held in Las Vegas in January offering a range of classes for developing the leadership and skills required for organizing and managing rodeo events. The IGRA Convention took place in Little Rock in November where rules and standards of competition were reviewed and updated. Four new members were inducted into the IGRA Rodeo Hall of Fame recognizing their lifetime achievements and contributions to gay rodeo. Work continued to build the archives of gay rodeo history, managing the current collection and searching for a permanent home where more of it can be made publicly accessible. The IGRA Royalty Team presented grants to several selected charities in recognition of their on-going contributions to the welfare of the LGBTQ community.

The 19 independent member gay rodeo associations send representatives to the IGRA annual convention each November to vote in elections for the Executive Officers (President, Vice President, Secretary, Treasurer) of the Board. Executive Officer vacancies occurring between conventions are filled by the full Board of Directors. Other appointments (committee chairs, employees, consultants, etc.) are subject to review, approval and dismissal by the full Board of Directors.

Form 990, Part VI, Section A. Line 7b (governance decisions)

The full IGRA convention body retains the authority to review, approve, suspend, or reverse decisions of the IGRA Board of Directors made between conventions.

Form 990, Part VI, Section B. Line 11b (organization review of Form 990)

The draft amended Form 990 and schedules for 2017 were presented to the full board of directors at their quarterly meeting in Denver, CO on July 5, 2019 for review and comment. Modifications stemming from that review were incorporated into the Amended 2017 Form 990. Additional amendments were needed after the IRS directed the organization to submit a 2016 Form 990 as the new initial return for the organization. This second amended return was reviewed and approved by IGRA Executive Board members for submittal to the IRS.
