CPC is an affiliate of the University of Colorado Health Anschutz Medical Campus and Denver Health & Hospital Authority and provides expertise in trial management and educational training for clinical research including medical affairs, biostatistical analysis, data and project management and regulatory affairs. Additionally, CPC provides:

- Leadership in the design and oversight of clinical trials by integrating sound clinical science and Steering Committee leadership, leading to peer-reviewed publications.
