During 2017, GCY facilitated a record 86 outdoor education programs river and land, serving a record 1,064 participants from across the country on 4,905 days in the outdoors. Programs took place on seven sections of river in Utah, Colorado and Arizona, including Grand Canyon. The GCY program continues to be one of the most affordable programs of its kind, charging up to two-thirds less than commercial river trips. Participants paid only 50 of the actual cost of operating the programs in 2017 the rest was funded by grants, contributions and special events.
