Cinderella Affair provides prom dresses, shoes and other prom necessities for local high school students since 2002. Approximately 2,000 dresses were provided in 2016 and 10,000 dresses were provided since program inception. The program provides beautiful new and gently used prom dresses to high school juniors and seniors from all around Arizona. The young ladies select shoes and jewelry to complete the look, making a once in a lifetime event affordable.

4b (Code) (Expenses \$ 5,000 including grants of \$) (Revenue \$)

Over the Moon Scholarship provides a scholarship in conjunction with the family of Stephanie Graham to a female student who exhibits service to the community, participation in extra-curricular activities, demonstrates financial need and has a minimum grade point average of 2.5. Emily Rosamond Scholarship provides a scholarship to an Arizona resident attending ASU full time, has a minimum grade point average of 2.75 and exhibits financial need. The scholarship honors the memory of Emily Rosamond Bauer, an ASU 2001 graduate and community volunteer. Anything Is Possible Scholarship provides a scholarship to a female student who exhibits service to the community, participates in extra-curricular activities, demonstrates financial need and is in the academic middle with a minimum grade point average of 2.5 or better. The scholarship is based on the Boards of Directors of the Organization and the Tempe Union High School Education Foundation belief that post-secondary education is key to the success for all students. Over \$200,000 in scholarships have been provided over the years.

4c (Code) (Expenses \$ 3,700 including grants of \$) (Revenue \$)

Success through Education, Exploration and Development for Autism (SEEDS) provides young adults with autism a place to go to socialize and continue learning once high school is over. SEEDS for Autism provides a path from learning to earning for young adults with autism through education, vocational training, and social skills development in Phoenix. Professional artists volunteer their time to teach participants job skills in wood working, ceramics, jewelry, metals and fibers. In turn, their works are sold at trunk shows or at the mobile boutique sponsored by East Valley Womens League.
