GACE previously reported only US activity on 990Ns. The organization in Togo was understood as having its own national status.

The Togolese entity received funds to its Togolese bank account directly from donors. We recently verified the organization in Togo is a foreign branch of GACE USA, not a separate organization. We are now bringing in all the foreign activity to the US returns.

FBARS for Togo bank account 2017 and previous years were filed in April 2018. We are amending 2013-2016 from 990Ns to 990s. Programs reported by GACE on its original 501(c)3 narrative remain the same. The mission & activities have not changed except as noted below.

However when the revenues and expenses from Togo were brought in to the 2017 return, it became necessary to file long form 990.

We also did not previously report non-cash donations in the US. Now these are in our amended returns 2013-2016 and return for 2017.

2017-2020 on a capacity building program with women shea collectors. The program empowers women community members to build trade cooperatives, & other community development projects, such as group savings pools and reforestation. GACE Washington Secretary of State incorporation documents included a purpose of supporting fair trade. But the GACE 501(c)3 original application narrative of projects did not include this purpose and activity. We would like to update the GACE 501(c)3 exempt purposes to match WA incorporation records.
