In addition, deferred income taxes are provided for temporary differences resulting from certain accrued expenses that are deductible only when paid and for net operating loss carryforwards available to offset future taxable income. Valuation allowances are used to reduce deferred tax assets to their estimated net realizable values when management determines ultimate recovery is not probable. In 2017, the Association adopted FASB Accounting Standards Update 2015-17, Income Taxes (Topic 740) Balance Sheet Classification of Deferred Taxes. The Update eliminates the requirement to separate deferred income tax assets and liabilities into current and noncurrent amounts within a classified balance sheet. All deferred income tax assets and liabilities are classified as noncurrent. The Association has adopted the Update prospectively. Accounting principles generally accepted in the United States of America require management to perform an evaluation of all tax positions taken or expected to be taken in the course of preparing the Association's tax returns to determine whether the tax positions meet a "more likely than not" standard of being sustained under examination by the applicable taxing authorities. This evaluation is required to be performed for all open tax years, as defined by the various statutes of limitations, for federal and state purposes. The Association is required to file federal and state income tax returns for the Service Corporation and the Service Agency. Management has performed its evaluation of tax positions taken on all open tax returns and has determined that there were no positions taken that do not meet the "more likely than not" standard. Accordingly, there are no provisions for income taxes, penalties or interest receivable or payable relating to uncertain income tax provisions in the accompanying consolidated financial statements. From time to time, the Association may be subject to penalties and interest assessed by various taxing authorities, which will be classified as administrative and other expenses, if they occur.
